#### AGENDA

1. Call to Order: 1:32 p.m.

Roll Call: Roll was taken with a quorum present.

- 2. June 5, 2025 Technical Advisory Committee Meeting Minutes: Mr. Anderson moved to approve the June 5, 2025 Technical Advisory Committee meeting minutes, and Mr. Reinert seconded the motion. The motion carried unanimously.
- 3. August Regional Transportation Improvement Program Amendments: Mr. Johnson presented this agenda item. He explained that there were three Regional Transportation Improvement Program (RTIP) amendments for the month, and one administrative modification submitted by the Samish Indian Nation. Anacortes' amendment for the 32nd Street at Storvik Park Pedestrian Crossing project adds the project to the RTIP. This project was awarded Carbon Reduction Program (CRP) funds through SCOG's project selection process earlier in the summer. The project is fully funded, with a total estimated project cost of \$180,500 including \$48,777 in local funds. Skagit Transit's amendment for the Skagit Station HVAC Repair project adds the project to the RTIP. The amendment adds all phases of the project to the RTIP, with a total estimated project cost of \$300,000, including \$152,184



in federal 5339 funds and \$147,816 in local funds. WSDOT's amendment for the SR 536/Skagit River Bridge Painting project revises a project already programmed in the RTIP. The total estimated project cost has been increased to \$14,289,575. Construction phase costs have been increased to \$12,432,427 in Highway Infrastructure Program funds and \$300,573 in state funds. The administrative modification for the Samish Indian Nation's SR 20/Campbell Lake Road Roundabout Project revises a project already programmed in the RTIP and does not require Transportation Policy Board action.

Mr. Dempsey motioned to recommend approval of the August Regional Transportation Improvement Program Amendments to the Transportation Policy Board as presented. Mr. Weller seconded the motion, and it carried unanimously.

- 4. Move Skagit Stakeholder Discussion: Mr. Frkonja presented this agenda item. The consultant team working on the Move Skagit planning effort gave an update on the Regional Transportation Plan, the Regional Safety Action Plan and the Transportation Resiliency Improvement Plan. The consultant team then gathered feedback from TAC members.
- 5. 2026-2031 Regional Transportation Improvement Program: Mr. Hamilton presented this agenda item. He explained that work is beginning on the 2026-2031 RTIP and that projects need to be submitted to SCOG by August 18th. He stated that this is work that SCOG does on an annual basis. The draft RTIP will come to the TAC for review at their September meeting, with adoption by the Transportation Policy Board anticipated at their October meeting.
- 6. Quarterly Obligation Report: Mr. Hamilton presented this agenda item. He stated that as of the date of this meeting, the region had obligated approximately \$500,000. The regional obligation target is just over \$2.6 million, and staff still expect that the region will ultimately obligate over \$4.5 million for Federal Fiscal Year 2025.
- 7. 2025 Obligation Authority Plan: Mr. Hamilton presented this agenda item. He gave an overview of obligation deadlines and project sponsors gave updates.
- 8. Project Selection Debriefing: SCOG staff tabled this presentation due to lack of time and will be bringing this item back to the TAC at their September meeting.
- 9. Roundtable and Open Topic Discussion: Technical Advisory Committee members provided project updates for their jurisdictions.





#### **DISCUSSION**

Skagit Council of Governments (SCOG) staff has been working with member jurisdictions to update the <u>Skagit Regional Transportation Priorities</u>. The Skagit Regional Transportation Priorities is an annual list of projects created as an information item for the state legislature to provide visibility for regionally important projects. The list includes information such as a project description, sponsoring agency, project cost, existing funding and funding needed. Projects have been updated based on information provided by member jurisdictions. Where applicable, programmatic funding need amounts have been updated based on best available estimates.

SCOG staff is in the process of gathering updates and finalizing the draft document prior to presenting it to the Technical Advisory Committee at their December 4, 2025 meeting for review and recommendation. SCOG staff anticipate that the Transportation Policy Board will take action on the 2026 Skagit Regional Transportation Priorities at the December 17, 2025 meeting.

Support Increased Funding for Regional Transportation Planning Organizations

Increase the Regional Transportation Planning Organization (RTPO) program budget to \$11.7 million in State Fiscal Year 2026-2027 and adjusted annually for inflation thereafter in order to achieve the transportation planning outcomes and requirements of RCW 47.80. The original biennial appropriation for the state-wide RTPO program (\$4.4 million) has not changed since the program's creation 34 years ago. RTPO's have an important responsibility to provide transportation planning in support of rural and tribal areas across the state. Duties outlined in RCW 47.80 include developing Long Range Transportation Plans, creating Transportation Improvement Plans and coordinating with local planning agencies. Since the creation of RTPO's, their duties have been expanded and RTPO's are struggling to keep up with the requirements at the current funding levels. Funding allocations have not increased over time to meet the rising costs of operations as well as the expanded responsibilities of RTPO's. SCOG supports an effort to completely assess the amount of funding required for RTPO's to perform their duties.

#### **WSDOT Highway System Needs**

Maintenance, preservation, safety, operations, seismic resilience, environmental retrofit and other needs are estimated at approximately \$61 million per year for the Skagit region. These needs are for Interstate 5 and state routes in Skagit County. Currently, 36% of these needs are funded. Environmental retrofits, principally to improve fish passage, are the highest estimated need.

#### **Local Roadway System Needs**

The vast majority of the roadway network in the Skagit region is owned and maintained by local jurisdictions. Maintenance and preservation needs for these local facilities are estimated at \$27 million per year. Of these local needs, nearly 60% are being met with available revenues (~\$16 million) and the other 40% are unmet needs (~\$11 million). Transportation benefit districts have been utilized in recent years by local jurisdictions to provide funding for maintenance and preservation, but these districts have not provided the funding necessary to address all unmet needs. Deferred maintenance due to these unmet needs are leading to further degradation of local roadways.


