



PUBLIC ENGAGEMENT ACTIVITIES

BACKGROUND

This section elaborates on specific public involvement activities conducted as part of the Skagit 2045 Regional Transportation Plan update. These activities are consistent with the adopted Public Involvement Plan. The COVID-19 pandemic necessitated that SCOG staff take a different approach to public involvement than had been done in years past. The following sections outline specific tools created and activities implemented to solicit public feedback for the Regional Transportation Plan update.

SKAGIT 2045 WEBSITE

Staff created a website at the domain www.skagit2045.org to act as a central landing platform for all virtual public involvement activities for the plan update. The website included a number of avenues for the public to engage with SCOG staff through the planning process. These included:

- E-newsletter subscription for monthly plan updates (also posted at skagit2045.org/updates)
- Interactive transportation priorities survey
- Interactive transportation comment map
- “Contact us” form for comment submission
- Open commenting on all staff posts
- Staff contact details
- Event details for public meetings

All text on the Skagit 2045 website was professionally translated into Spanish, which is consistent with SCOG’s Title VI Plan. A Spanish language e-newsletter was also available for those interested. The Spanish language version of the website linked to Spanish language versions of the additional public involvement tools, including the transportation priorities survey and comment map.

A screenshot of the Spanish language homepage of the website is included in Figure 1 below.

Between September 2020 and January 12, 2021, the Skagit 2045 website was visited by 677 unique users, over 786 unique sessions. The website was most commonly accessed by those using English and Spanish languages in their internet browsers. The most common user locations identified by Google Analytics for the website include Mount Vernon, Seattle, Oak Harbor, Camano Island, Anacortes, and Sedro-Woolley.

In all, around 51% of users accessed the Skagit 2045 from mobile devices such as smartphones. Around 42% of users accessed the website from desktop computers, and the remainder of users accessed the website via tablets.

TRANSPORTATION PRIORITIES SURVEY

The main tool for soliciting public feedback during the planning process was the transportation priorities survey, hosted through SurveyHero. This survey included 13 questions outside of demographic questions, and was available in English as well as Spanish. Questions focused on prioritizing project outcomes (related to project types,) along with funding tradeoff questions. The entire survey is available at the end of this section.

PROMOTION AND ADVERTISING

Promotion and advertising for the transportation priorities survey occurred in September and October, 2020. Advertising strategies included the following:

- An article published in Skagit Valley Herald newspaper;
- A radio interview with KSVR FM on their “Skagit Talks” radio show; and
- Online advertising through Facebook paid advertisements.

As a practice, SCOG does not use social media for public engagement. For the purposes of this planning process, a Facebook page was created with no opportunity for the public to engage with the page. This allowed staff to create paid Facebook advertisements. The target audience selected for the advertisements was those residing in Skagit County, with a minimum age of 16.

Targeted Spanish language advertisements were also created to reach those who were using Spanish as their selected language on Facebook. These advertisements directed respondents to the Spanish language survey. Figure 2 shows the advertisements used to solicit responses to the survey.

TRANSPORTATION COMMENT MAP

Another strategy piloted during the Regional Transportation Plan update was the creation of an interactive comment tool through ArcGIS Online’s “Crowdsource Reporter” app. This app allowed staff to create editable GIS layers where the public could drop a pin on a location and submit a themed comment about transportation issues anywhere in the Skagit region.

Comments were divided into six different themed categories. These included:

- Active Transportation
- Freight and Aviation
- Infrastructure and Environment
- Traffic Congestion
- Traffic Safety
- Transit and Ferries

Figure 2 illustrates how demographic information could also be collected about those who responded to submit their comments. This allowed staff to better understand which areas of Skagit County had the most and least involvement in the planning process, and where future planning efforts may prioritize better outreach.




Figure 3: Transportation comment map displaying “add a comment” fields




Figure 4: Transportation comment map legend illustrating available comment types

Comments were further classified by comment type under each category. Each category was defined by a separate comment layer with a unique legend for comment types. An example of the “Infrastructure and Environment” comment legend is included in Figure 4 below.
